**Abstract:** Elderspeak is a form of ageism in which individuals speak at a slower rate, in a louder voice, and use overly- endearing terms when communicating with older adults. Most older adults have at least one chronic health condition, and the rate of hospitalization increases with age. Educating health-care professionals, specifically nurses and nursing students, about the importance of competently communicating with older adults is vital in ensuring positive health outcomes for this population.

example of elderspeak communication was identified in 84% of transcripts." (Williams

et. al., 2017, p. 5); and

WHEREAS, Health-care professionals frequently stereotype older adults leading to inappropriate

and demeaning verbal interactions. (Alden & Toth-Cohen, 2015, p. 2); and

WHEREAS, According to the Journal of Gerontological Nursing, "Educating nursing home staff about

elderspeak and its implicit messages has been successful in reducing staff use of

elderspeak," (Williams et. al., 2017, p. 9-10); therefore be it
